## APPLICATION FOR COMPETITION PERMIT

I hereby give oath that I have no knowledge that this horse has ever been registered by the Appaloosa Horse Club of Canada.

This application is submitted subject to the following:

- 1) that this gelding, mare or spayed mare must be a fully Appaloosa-coloured horse over 14 hands high and five years of age or older;
- 2) the Competition Permit Veterinarian/ApHCC Inspector Evaluation must be completed in full by a veterinarian or ApHCC Inspector and approved by the Appaloosa Horse Club of Canada;
- 3) **a \$100.00 fee plus applicable taxes shall accompany this application;**
- 4) approval of this application will permit this horse to compete in all Appaloosa Horse Club of Canada recognized events, in all classes EXCEPT conformation at halter. This horse will NOT be recognized by the ApHCC for breeding purposes;
- 5) the sale of a horse issued a Competition Permit shall negate the permit and the new owner must reapply meeting all conditions;
- 6) the Appaloosa Horse Club of Canada has the privilege to correct and/or cancel a Competition Permit for causes under its rules and regulations;
- 7) four photos of the horse must accompany this application (one of each complete side, one of direct head view & one of direct hind view).

I make this solemn declaration that the information contained herein is factual, and the truth. The above description accurately describes the horse named on this application.
