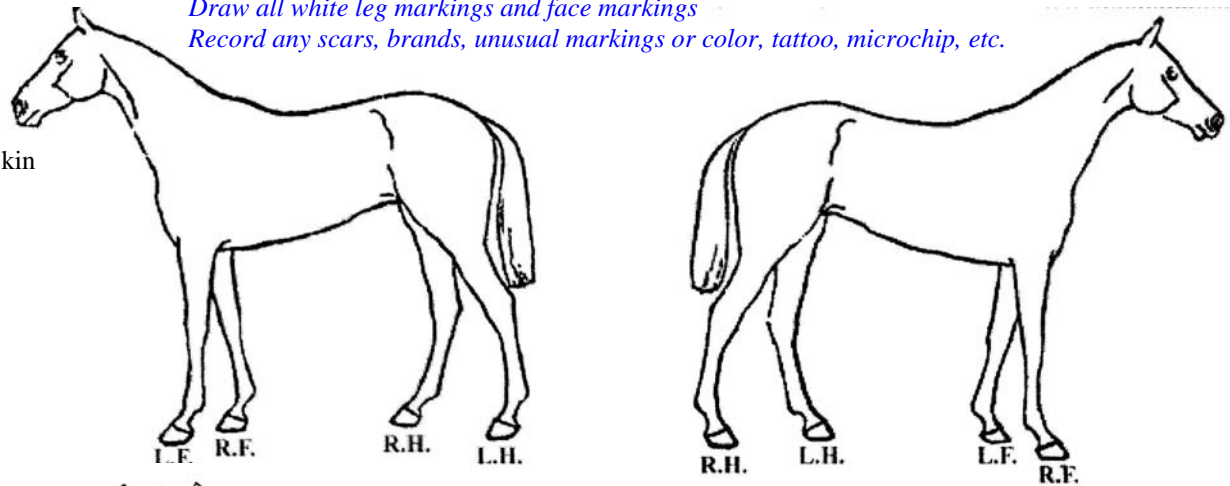

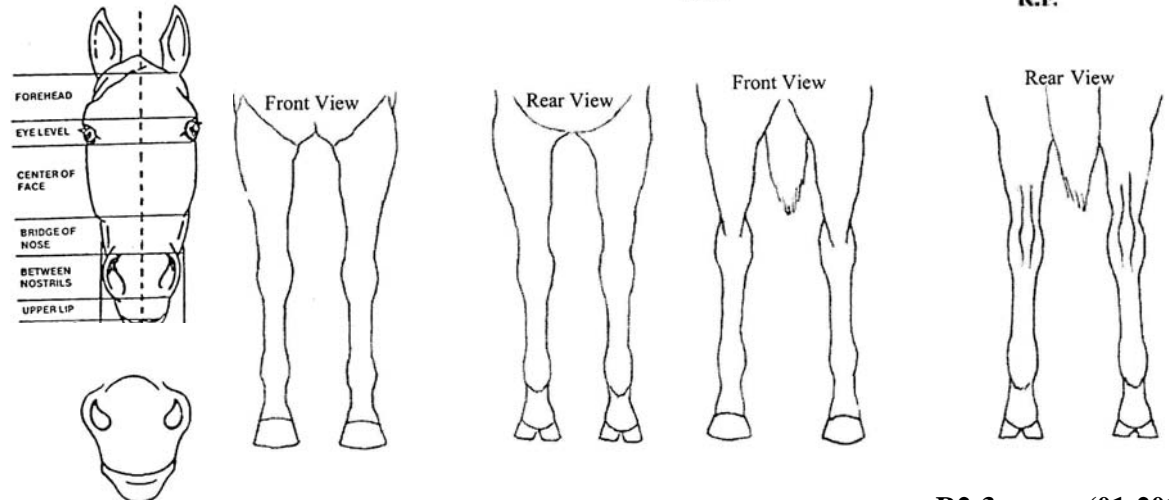

These additional photos will be required before the Registrar may consider issuing a certificate for the applicant horse.
6. The Stallion Report for the year of breeding must be on file with the ApHCC and all applicable fees paid in order to complete the application.
7. If the sire or dam is a registered Quarter Horse, Thoroughbred, or USA owned ApHC Appaloosa, a Registration Certification form, listing fee (\$60.00 member rate or \$120.00 non-member rate), and copy front and back of the horse's certificate must be on file with the ApHCC. This is a one time listing of the outcross parent.
