# APPLICATION FOR TRANSFER OF OWNERSHIP

ApHCC Regulations Part 4 and ApHCC Regulations Part 1. C.

This Transfer of Ownership **must** be completed in ink or type written, **must** be signed by the owner(s) or authorized individual(s), as per the ApHCC official records, and **must** be accompanied by the required fees. The date of sale **must** be recorded on this application for Transfer of Ownership. The seller is obliged to supply the duly transferred certificate to the buyer within six (6) months after the date of sale in accordance with the terms and conditions of the *Animal Pedigree Act, 1988*. Refusal to do so under any pretext whatsoever, except under written agreement to the contrary, dated and signed by the seller and the purchaser, shall be grounds for suspension or expulsion from the ApHCC if a Member; if not a Member, any applications for registration or transfer shall be denied until the matter is resolved. If the beneficial owner of property named in this document is under the age of majority in the province of residence of the named beneficial owner, then a trustee **MUST** sign and be named as the owner/applicant/seller/purchaser in the designated area of the form, as "in trust for", and include the relationship to the minor child for example; *Elaine Smith, trustee James Smith (parent)*.
