- Canadian Stock Horse Championships divisions will run concurrently within the equivalent Canadian National Appaloosa Show (CNAS) Working Cow Horse Classes. The decisions of the officiating judges and/or the governing, Appaloosa Stock Horse Organization, (ASHO) Board of Directors are final. All Canadian Stock Horse Championship entrants must also be entered in the CNAS equivalent class(es). Please note CNAS entry deadline for all cattle classes is June 15, 2010.
- Paybacks and prizes in the Canadian Stock Horse Championships will be per the ASHO pay scale & rules. 0% of the entry fees will be retained. Any added purse will be pro-rated by entry numbers.
- A copy of the horse's papers must accompany this entry form.
- Payment can be made by Cash, Cheque, Money Order or Draft payable to Appaloosa Stock Horse Organization. There will be no refunds given for any reason.
